Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 ('Listing Regulations'), we wish to inform you that Mr. Leo Puri (DIN: 01764813), has tendered his resignation as the Independent Director of the Company, with effect from close of business hours on 30th June, 2025, due to an increase in his board commitments including his proposed appointment on the board of a global entity and the overboarding criteria for Independent Directors as prescribed under the European Corporate Governance requirements. Consequent to his resignation from the Board, he shall also cease to be the Chairperson of the Risk Management Committee, ESG Committee and Independent Committee and a Member of Audit Committee of the Company, with effect from close of business hours on 30th June, 2025.

**Subject: Resignation as an Independent Director of the Company**

I am writing to inform you of my decision to step down from the position of Independent Director of the Company and consequently from the Chairmanship and membership of the Board Committees of which I am a part. Regretfully, I have had to take this decision to step down on account of my other Board commitments, both domestic and international that I need to attend to.

I was appointed as an Independent Director, on the Board of Directors (the Board) of Hindustan Unilever Limited (the Company) with effect from 12th October, 2018 and

re-appointed with effect from 12<sup>th</sup> October, 2023.

Due to the recent proposed appointment on the board of a global entity, (pending approval from the shareholders), and the overboarding criteria for Independent Directors under the European Corporate Governance requirements, I have after due consideration, decided to step down and hereby tender my resignation as an Independent Director of the Company with effect from close of business hours on 30th June, 2025.

Consequent to my resignation from the Board, I will also be stepping down as the Chairperson of the Risk Management Committee, ESG Committee and Independent Committee and as a Member of Audit Committee of the Company.

I deeply regret that I am unable to complete my term at Hindustan Unilever Limited. I remain committed to supporting the company in any way I can during this transition.
